Church of Christ JUNIOR PARKING RULES AND REGULATIONS 2022-2023

Parking at The Church of Christ is a privilege and not a right. The following regulations must be followed to allow for the convenience and courtesy for the greatest number of people at the church. The following regulations apply to all students parking vehicles:

- All vehicles must have a MHS church-parking permit in the lower passenger corner of the windshield. Each student may purchase only ONE permit. In the event a student needs a replacement permit (e.g., new vehicle, windshield is replaced, etc.) a new sticker must be purchased for \$25. Permits are non-transferable. If the old sticker appears on another student's vehicle, both students will permanently lose parking privileges at MHS.
- 2. Permits are non-transferable. They are issued to a specific vehicle and a specific student. In order to be issued a permit, the vehicle must be registered to (owned or leased by) the student or student's family. In addition, the student's name must appear on the insurance card.
- 3. The permit is not valid unless **PERMANENTLY** attached to the windshield in the lower passenger corner.
- 4. Juniors with a MHS church parking lot sticker may only park in The Church of Christ parking lot. Vehicles should be parked <u>only in the red parking spaces</u> in the parking lot. If students vehicle is found on the MHS campus (between 7am-3pm), the vehicle will be issued the appropriate violation.
- 5. All vehicles parked at the church are subject to search and seizure if deemed appropriate by school administrators.
- 6. Students who park in the church lot must use the crosswalk or sky-bridge to cross Echo Lane. The crosswalk is there for your safety.
- 7. Students who leave campus during school hours without permission are subject to having their parking permits revoked in addition to other disciplinary consequences.
- 8. Students **MAY NOT** park in the following locations:
 - Faculty Parking Area
 - Visitor and Staff parking
 - Fire, loading and unloading zones
 - Driveways, freight lanes, entrances, and sidewalks
- Handicapped spots
- Field House parking lot
- Back Parking lot
- Senior Parking lot
- 9. Students who are illegally parked are subject to disciplinary and/or legal action, including having their parking permits revoked, being issued police citations, and having their vehicles towed. The principal in charge of campus parking maintains a computer list of all parking violations.
- 10. Use or distribution of counterfeit parking permits will result in immediate revocation of parking privileges and disciplinary action.

- 11. Temporary parking permits must be used when not driving the vehicle that is registered at this school. These are available in the Grade Level Office and must be picked up **BEFORE** school begins. Misuse of temporary parking permits may result in appropriate disciplinary action.
- 12. All vehicles parked at the Church of Christ parking lot must be removed from the church parking lot by 3:20 p.m. Any car left in the lot after 3:20pm will be towed at the owner's expense.
- 13. Memorial High School has the right to close parking at the church lot if the parking lot is left trashed.

A note of caution: There are no arrangements for students to use any shopping center parking. Freshmen and sophomores will not be issued parking permits.

STUDENTS WHO ARE ILLEGALLY PARKED ARE SUBJECT TO DISCIPLINARY ACTION, TOWING, AND LOSS OF PARKING PRIVILEGES.

VIOLATIONS AND CONSEQUENCES

- 1st Offense a warning sticker will be issued and 2 hours of afterschool detention.
- 2nd Offense a warning sticker, 4 hour Saturday detention will be issued, and parking privileges will be suspended for one week.
- 3rd Offense a warning sticker, 1 day of ISS, vehicle will be towed at the owners expense, parking privilege revoked for 30 days, and a new parking sticker must be purchased. A third parking violation may result in the loss of future parking privileges.

NOTE: Regardless of whether or not a valid student permit is displayed, citations will be issued for motor vehicle violations such as parking in handicap spots, fire zones, blocking sidewalks, parking on curbs, etc.
